Norfolk County Council Updates

Devolution update

Following a discussion at full council on 16 October, Norfolk County Council's cabinet have voted in favour of proceeding with devolution.

Devolution will bring new powers and funding to boost jobs, transport, housing and growth in Norfolk and Suffolk. Under the Government's devolution priority programme, Norfolk and Suffolk have been offered:

- The transfer of powers and funding from Whitehall, to enable decisions on jobs, skills, transport and housing to be taken in Norfolk and Suffolk.
- A multi-million pound investment fund for 30 years, to spend on local priorities.

The new devolved powers and funding would be overseen by a mayor, elected by voters in May 2026, to lead a new combined authority.

Norfolk County Council Adoption Service

Norfolk is outperforming the national trend when it comes to recruiting adoptive parents. Whilst there has been a 12% drop in families considering adoption across England this year, Norfolk County Council's Adoption Service has seen a significant rise. In 2024/25, 43 adoptive households were approved in Norfolk - a 53% increase on the previous year. These included 37 couples and six single adopters.

This positive news comes as the council celebrates National Adoption Week (20–26 October), which this year focuses on dispelling myths about who can adopt. Research shows that many prospective adopters worry they need a "perfect" home, but the reality is that children simply need a welcoming and loving environment. In fact, 41% of adoptive parents surveyed live in homes with two bedrooms or fewer, 65% do not have a garden, and 25% live in rented accommodation.

New Norfolk-wide highways contract

Norfolk County Council has appointed Kier as its new long-term contractor responsible for the maintenance and construction of the county's highway network.

Norfolk's highway network is one of the largest in the country, comprising around 6,000 miles of roads as well as extensive pedestrian and cycle paths. Kier will deliver a programme of highways maintenance and improvement, including road resurfacing and surface dressing, bridge works, drainage and the delivery of new transport infrastructure.

As part of the contract, Kier will invest in its existing site in Wymondham - upgrading facilities to reduce energy consumption and support the latest in sustainable construction and materials innovation, which will benefit the wider Norfolk economy.

A key feature of Kier's approach will be its commitment to local skills and employment. At any given time, Kier will employ at least 15 apprentices, providing structured training, professional qualifications, and career pathways for young people across Norfolk. The company will also run an annual 10-week programme for young people in care and care leavers, offering taster sessions, work experience, and employability skills, with support from supply chain partners.

Support for the delivery of the Great Yarmouth offshore wind hub

The <u>National Wealth Fund has announced</u> a £15m loan, through Norfolk County Council, to back an operations and maintenance (O&M) centre that will support major offshore wind projects off the east coast.

NWF's financing will fund the delivery of the hub, including 240 metres of refurbished river quay, a new purpose built pontoon for offshore wind Crew Transfer Vessels, and upgrading shore infrastructure and utilities connections. These improvements will support major offshore wind projects off the east coast, positioning Great Yarmouth and Norfolk as leaders in the UK's offshore wind supply chain.

Norfolk County Council, in partnership with Great Yarmouth Borough Council and the Ministry for Housing, Communities and Local Government, is leading on the delivery of this £28m project with construction already underway.

The project is expected to create around 650 new jobs locally, providing significant economic opportunities for residents and businesses.

The offshore energy sector presents one of the most significant economic opportunities for Great Yarmouth and Norfolk, and in regenerating industrial land near the town's port into a state-of-the-art facility, the region is further positioning itself to capitalise on this growth.

New business park in North Norwich

A business park being developed on the edge of Norwich with the support of a loan from Norfolk County Council is expected to result in 1,250 new jobs, plus supply chain and construction.

The scheme was able to get off the ground thanks to a £1m loan from Norfolk County Council to help finance the site infrastructure.

Infrastructure works have just been completed on Phase 1 at the 100-acre Broadway Enterprise Park, close to Norwich Airport, that includes the Norwich North Recycling Centre and will host a mix of commercial and industrial premises, warehousing, as well drive-through restaurants.

National Updates

Post-16 Education and skills white paper

The Government has published a <u>Post-16 Education and Skills White Paper</u>, setting out major reforms to simplify qualifications, boost skills, and align education with economic needs.

The reforms aim to improve outcomes for young people, support adult learners, and ensure that education and training provision meet the needs of local employers and communities.

Key proposals include:

- New "V-Levels" to replace most vocational Level 3 qualifications, offering flexible options alongside A-levels and T-levels.
- Reformed Level 2 pathways from 2027, with clearer routes into further study or employment.
- Support for GCSE resits, including new stepping-stone qualifications in English and maths.
- Lifelong Learning Entitlement for adults, enabling modular study and access to fee loans for up to four years.
- Growth & Skills Levy to help employers fund short courses and apprenticeships in priority sectors.
- Expansion of Technical Excellence Colleges, including in clean energy, digital and advanced manufacturing.

- £800m investment in 16–19 education, alongside a national CPD programme for FE staff.
- Stronger local governance, with Strategic Authorities playing a key role in shaping regional skills plans.

Clean Energy Jobs Plan

The Government has <u>published</u> a national plan to recruit and train the 'next generation' of clean energy workers, aiming to double employment in the sector to 860,000 by 2030.

For young people these jobs can offer higher levels of pay, with entry level roles in the majority of key occupations paying 23% more than the same occupations in other sectors.

According to government figures, jobs in wind, nuclear, and electricity networks all advertise average salaries of over £50,000, compared to the UK average of £37,000, and are spread across coastal and post-industrial communities.

Mandatory reading test for year 8 pupils

The Education Secretary has confirmed that all pupils will sit a mandatory reading test at age 13 (in year 8) in a bid to drive up reading standards. This new measure aims to set clear expectations to support parents, teachers and pupils, identifying gaps early and targeting help for those who need it, while enabling the most able to go further.

The Government is also expanding its support in reception year through the English Hubs programme, which will focus on the children who struggle the most, alongside reforms to boost the quality of early years education, and wider family support through Best Start Family Hubs.

Schools White Paper delay

The Education Secretary has <u>written to the Education Select Committee</u> following their report on the special educational needs and disability (SEND) system. Her letter includes information about the Schools White Paper (that was due in the coming weeks), saying it will not be published until "early in the new year".

Financial penalties for environmental offences – new consultation

Water companies who commit environmental offences could face quicker penalties of up to £500,000, under changes being considered by the government.

A <u>consultation has been launched</u> to expand and strengthen the current range of financial penalties available to the Environment Agency in a bid to clamp down on more offences.

The consultation closes on 3 December 2025.
