6. To receive updates regarding the condition of the gravel tracks & roadways around the Green

As per last meeting a resident has agreed that they will repair the track up to their property by the end of the year. We are hopeful that the work will take place. All other tracks are looking ok.

7. To note recent permissions given to undertake works on The Green

- The new residence at 94/95 asked to recreate a track. Permission has been given by Breckland council already for the removal of a tree and hedge. The Trustee has given permission to recreate the track.
- A parishioner has asked to reroute rainwater away from Kennel House from a downpipe to a ditch. Permission has been given for a pipe to be laid underground from the gutter to the ditch.
- Permission has been given to place a skip on the Green at the White House for renovation work at the property. The grass will be repaired if needed.

8. To receive an update regarding any further maintenance work on the pond, including tree work at the pond area and agree actions necessary and/or funding

Cllr McClenaghan noted that the pond will always require ongoing maintenance and the Trustee will be looking for volunteers to undertake the work and someone to oversee it. Cllr McClenaghan will approach Mr Romanovsky to see if he is interested in continuing to lead on this work.

9. To discuss any other issues pertaining to the Green

There are still people driving over the Green to get to parking spaces which is not acceptable. There is no excuse for driving up Kennel House's drive and then cutting across the grass. This has been added to the next newsletter to remind residents. It was reiterated that people should stop driving across and parking on the Green if possible. If this continues to happen people will be written to. Prefer not to put big signs on the Green. J Hargreaves suggested that flagship be approached to gravel some of the back of the properties so that people can park there instead of the Green. J Hargreaves to approach Flagship.

Time Allocated to the Public

- Parishioner asked about a wayleave being in place for Kennel House to take surface water away from the house.
- Parishioner noted that there is unwanted parking in other areas of the Green. Cllr McClenaghan invited the parishioner to let the Trustee know who the owners are that are driving on the Green.
